TO CONSIDER AND APPROVE A SELECTION OF STREET NAMES FOR CONSIDERATION BY BOLTON COUNCIL DEPARTMENT OF PLACE FOR THE DEVELOPMENT ON LAND AT THE FORMER HORWICH LOCO WORKS:

FG 7362 All Members had received copies of an email trail between various Councillors and Bolton Council Department of Place on this matter and a list of suggested names.

Councillor Wright arrived at this point.

Following a lengthy discussion Members were in agreement that it was important that Bolton Council should take on board Horwich Town Council's recommendations regarding naming of new streets, as previous policy had not taken into account neither the history or industrial heritage of Horwich. There were two different proposals for consideration, firstly, that the names should be those of the fallen from two World Wars which appeared on the Loco Works War Memorial, and a second that the names chosen should represent the industrial heritage of Horwich, in particular its railway history.

It was proposed that suggestions for new street names should be taken from the Loco Works War Memorial, with the method for selection to be decided, however this motion was not carried due to a lack of support.

The second proposal was voted on and it was resolved to submit suggestions for new street naming to Bolton Council which reflected the railway heritage of Horwich to include:

- Railway Road, Mechanics Way, Institute Way, Matilda Way, Gresley Way (although acknowledged that there was already a Gresley Avenue in Horwich), Whittle Way, Roe Way
- Festubert Way to commemorate those Loco Works employees who lost their lives during the battle of Festubert during the First World War
- Ronson Way to recognise the contribution to the local community made by Bob and Barbara Ronson, former Councillors Mayors and Freemen of Horwich

- Queen Elizabeth Way as a fitting tribute for next year's Platinum Jubilee
- individual Councillors offered to contact Horwich Heritage and ask for suggestions for additional names which reflected the railway history of Horwich.
